


DAYLIGHT SAVINGS TIME (DST)

HOURLY EMPLOYEES: HOW DOES DST AFFECT GRAVEYARD SHIFTS?

Employees who work graveyard shifts when DST begins will work an hour less due to clocks shifting an hour ahead.

FOR EXAMPLE:

The Shift is 11 PM - 7:30 AM (8 HRS) - DST begins at 2 AM on 3/10/24.

The employee doesn't work from the hour 2 AM - 3 AM because all of the clocks have turned an hour ahead. Thus, on this day, the employee actually worked 7 hours.

The FLSA requires that employees must be credited with the hours actually worked.



IRS UPDATES MILEAGE RATE

STANDARD MILEAGE RATES FOR 2024:

- 67 cents/mile driven for business use.
- 21 cents/mile driven for medical or moving purposes for qualified active-duty members of the Armed Forces.
- 14 cents/mile driven in service of charitable organizations.

These rates apply to electric & hybrid-electric cars as well as gasoline & diesel-powered vehicles.

TORNADO PREPAREDNESS

IDENTIFY SHELTER LOCATIONS

- An underground area, such as a basement, provides the best protection.
- Stay away from doors, windows, & outside walls.
- Avoid auditoriums, cafeterias, & gyms that have flat, wide-span roofs.

CREATE SAFETY PROCEDURES

- Develop a system to identify who's in the building.
- Establish an alarm system to warn workers.
- Assign specific safety duties to workers in advance.
- Get emergency supply kits to keep in shelter locations.
- Create training & exercises for workers to ensure that they know what to do in case of an emergency.

FLOOD RESPONSE

DRIVING DURING FLOOD CONDITIONS

Only 6 inches of standing water is enough to stall some cars, I foot of water can float a vehicle, and 2 feet of water is enough to sweep a car away.

• Do NOT try to cross flooded roadways if you do not know the depth of water.

DOL PROPOSES SALARY OVERTIME RULE

WHAT TO EXPECT

The Department of Labor proposed a rule that will increase the minimum salary threshold for the "white collar" overtime exemption rule under the Fair Labor Standards Act (FLSA) from \$35,568 annually (or \$684/week) to \$55,068 annually (or \$1,059/week).

Workers with a salary below this threshold must be paid overtime if they work more than 40 hours a week, if the rule is finalized.

What is considered a "white collar" position?

Employees who primarily perform executive, administrative or professional duties (EAP).
